General Norms:

Applications for Admission to Classes 1 to 8 and class 10 for the academic year 2024-2025 are open only for the Defence Category. Due to their frequent transfers, a limited number of vacancies are available under Defence Quota.

Only the serving Defence Personnels' wards (Army, Airforce and Navy) will be eligible for this round of admission. In case of Civil Defence Personnel, only those who have come on transfer since January 2023 will be eligible in this category.

At present, admissions are not open for the General Category due to lack of vacancies in this category. However, parents may submit their written applications (not formal application forms) with the photocopy of their ward's final report card and parents' details. In case, vacancies arise in this category in future, they will be intimated **accordingly**.
